November 2016



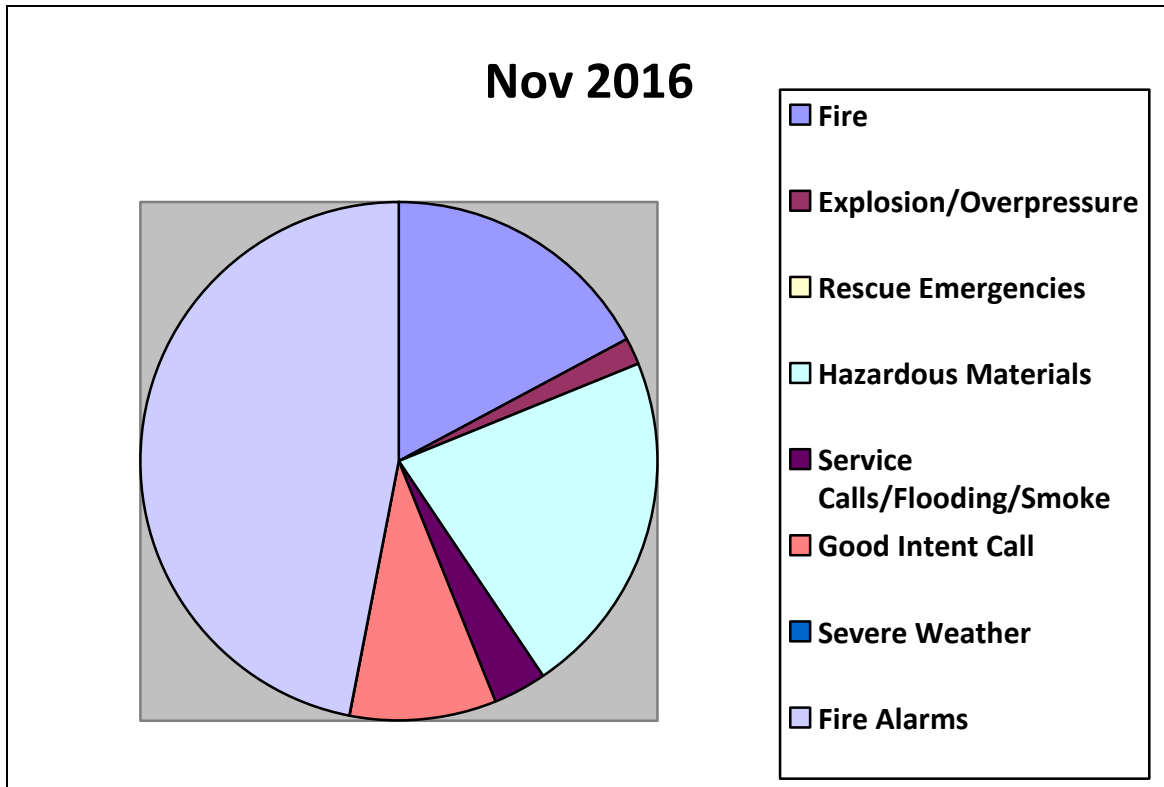

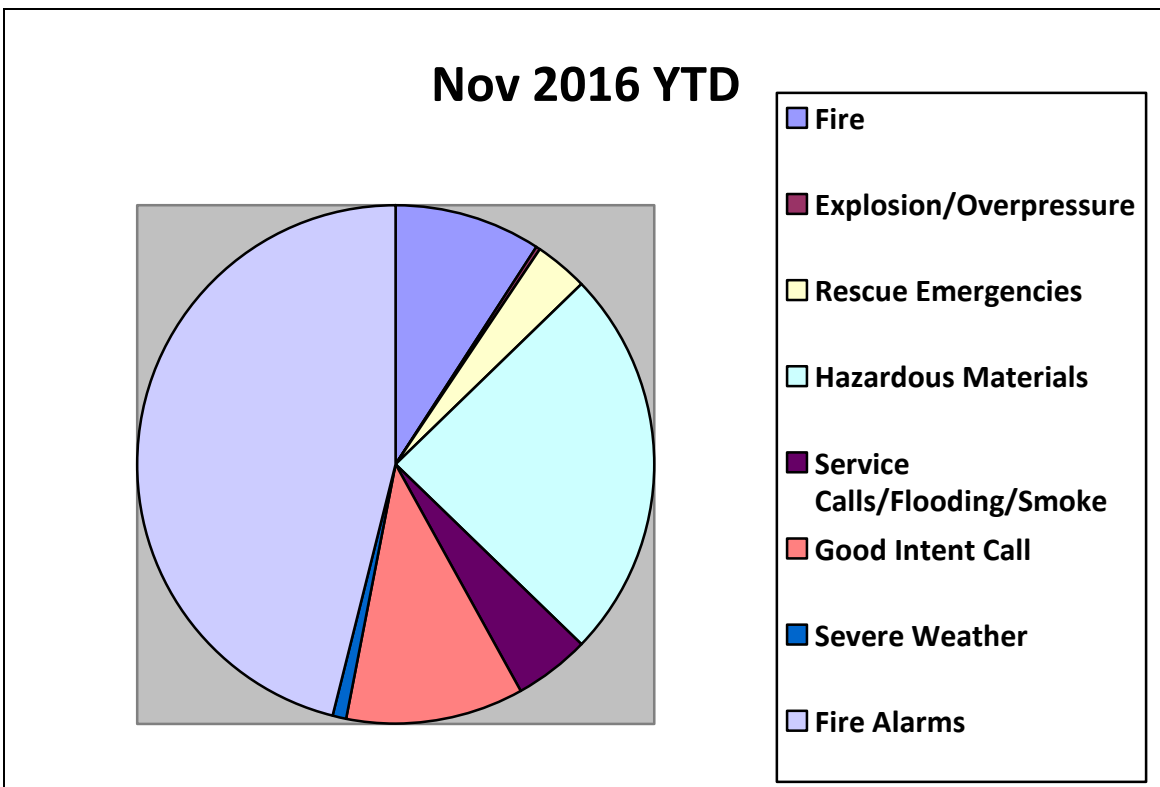
