February 2015



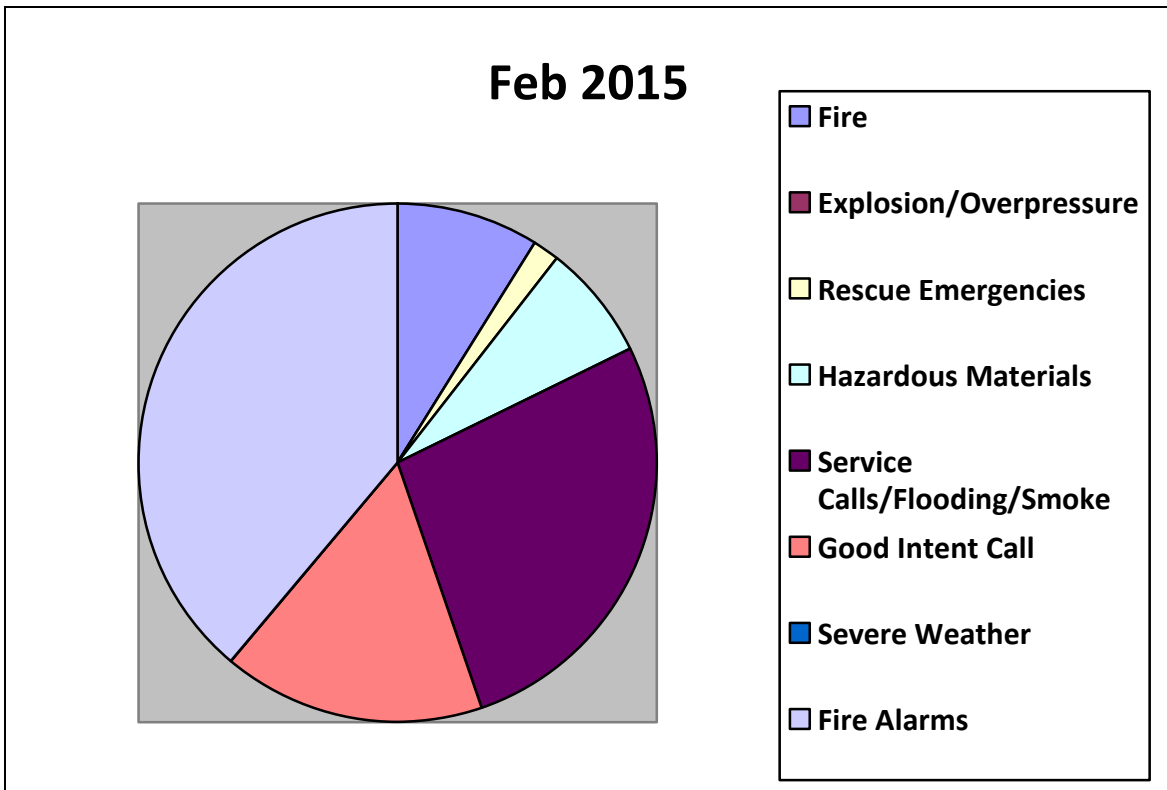

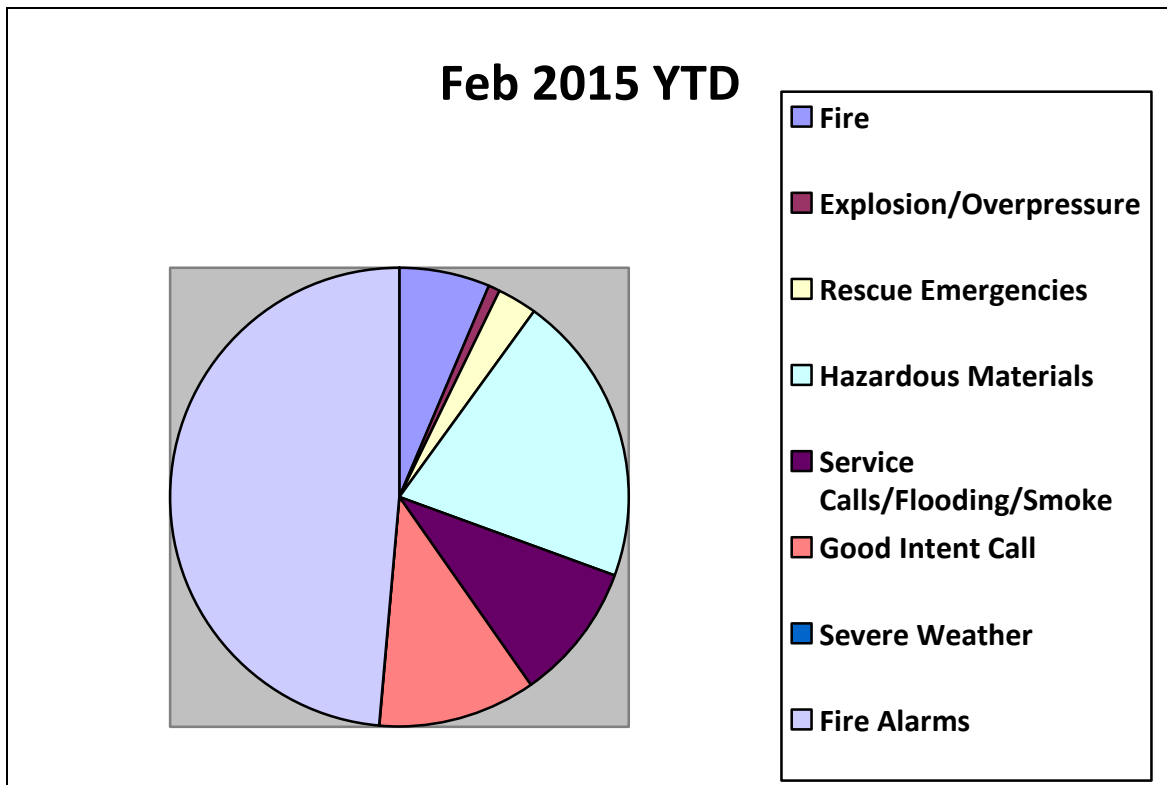
